

AN ORDINANCE AMENDING SECTION 86-621 OF THE BRANSON MUNICIPAL CODE PERTAINING TO SCHEDULE 1 - STOP SIGNS.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BRANSON, MISSOURI, AS FOLLOWS:

Section 1: It is the intention of the Board of Aldermen, and it is hereby ordained that the provisions of this ordinance shall become and be made a part of the Branson Municipal Code, and the sections of this ordinance may be renumbered to accomplish such intention.

Section 2: That Chapter 86 – *Traffic and Vehicles*; Article X. – *Schedules*; Sec. 86-621 – *Schedule 1 – Stop Signs* of the Branson Municipal Code is hereby amended to read as follows:

**CHAPTER 86 – TRAFFIC AND VEHICLES**  
**ARTICLE X. – SCHEDULES**

**Sec. 86-621. - Schedule I - Stop signs.**

In accordance with section 86-214 and when signs are erected giving notice thereof, traffic at the intersections listed in this section shall be required to stop as specified in this section before driving onto or across any street within the city upon which any state or federal highway is routed.

Section 5: That the City Clerk is authorized by this Ordinance to correct any scrivener's errors identified with in this Ordinance.
