

AN ORDINANCE AMENDING APPENDIX A OF THE BRANSON MUNICIPAL CODE PERTAINING TO WATER AND SEWER RATE ADJUSTMENT OF THE UTILITIES FEE SCHEDULE.

WHEREAS, a public hearing notice was published at least 30 days in advance of this date to satisfy the requirements of RSMo Section 250.233 regarding changes to water and sewer rates; and

WHEREAS, a public hearing was held during the October 8, 2024 Regular Meeting; and

WHEREAS, in accordance with the results of the public hearing, the recommendations of the consulting engineers and the estimated operational costs of the treatment works, hereby establishes just and reasonable rates and monthly charges to be used for the customers classifications established in Branson Municipal Code Section 90-31.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BRANSON, MISSOURI, AS FOLLOWS:

Section 1: It is the intention of the Board of Aldermen, and it is hereby ordained that the provisions of this ordinance shall become and be made a part of the Branson Municipal Code, and the sections of this ordinance may be renumbered to accomplish such intention.

Section 2: That Appendix A – FEE SCHEDULE of the Branson Municipal Code is hereby amended to read as follows:
