2 **AN ORDINANCE AMENDING SECTION 2-28 OF THE BRANSON MUNICIPAL CODE**
3 **PERTAINING TO ADMINISTRATIVE/SUPERVISORY COMMITTEES.**

6 **NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE**
7 **CITY OF BRANSON, MISSOURI, AS FOLLOWS:**

9 Section 1: It is the intention of the Board of Aldermen, and it is hereby ordained that the
10 provisions of this ordinance shall become and be made a part of the Branson
11 Municipal Code, and the sections of this ordinance may be renumbered to
12 accomplish such intention.
13

14 Section 2: That Chapter 2 – *Administration*; Article II. – *Mayor and Board of Aldermen*;
15 Division 1. – *Generally*; Sec. 2-28. – *Administrative/supervisory committees* of the
16 Branson Municipal Code is hereby amended to read as follows:

18 **CHAPTER 2 – ADMINISTRATION**
19 **ARTICLE II. – MAYOR AND BOARD OF ALDERMEN**
20 **DIVISION 1. – GENERALLY**

22 **Sec. 2-28. - Administrative/supervisory committees.**

- 24 (c) The duties of the finance committee shall be:
25
26 (1) To review and recommend the operations budget to the board.
27
28 (2) To review and recommend changes to the city's purchasing and accounting procedures
29 to the board.
30
31 (3) To review and recommend to the board procedures necessary to ensure the financial
32 health of the city.
33
34 (4) To assume other responsibilities as may from time to time be assigned by the board.

36 (5) To review and recommend capital improvements to the board each fiscal year.
37
38 (d) The mayor and city administrator shall serve on each of the committees mentioned in this
39 section along with the appointed members of the board.
40
41 (e) Additionally, the mayor and the board may appoint **three** citizens to serve on each of the
42 committees. Appointees must be a citizen of the city or associated with a business operating
43 inside the city limits.

46 (f) Each committee shall adopt procedures as necessary to allow for the efficient administering
47 of their assigned duties.

49 (g) Each committee member shall have a right to vote.

54 Section 3: This ordinance shall be in full force and effect from and after its passage by the
55 Board of Aldermen and approval by the Mayor.

57 Section 4: That should any section, sentence or clause of this Ordinance be declared invalid
58 or unconstitutional, such declaration shall not affect the validity of the remaining
59 sections, sentences or clauses.

61 Section 5: That the City Clerk is authorized by this Ordinance to correct any scrivener's errors
62 identified within this Ordinance.
