

AN ORDINANCE AMENDING SECTION 2-28 OF THE BRANSON MUNICIPAL CODE  
PERTAINING TO ADMINISTRATIVE/SUPERVISORY COMMITTEES.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE  
CITY OF BRANSON, MISSOURI, AS FOLLOWS:

- Section 1: It is the intention of the Board of Aldermen, and it is hereby ordained that the provisions of this ordinance shall become and be made a part of the Branson Municipal Code, and the sections of this ordinance may be renumbered to accomplish such intention.
- Section 2: That Chapter 2 – *Administration*; Article II. – *Mayor and Board of Aldermen*; Division 1. – *Generally*; Sec. 2-28. – *Administrative/supervisory committees* of the Branson Municipal Code is hereby amended to read as follows:

**CHAPTER 2 – ADMINISTRATION**  
**ARTICLE II. – MAYOR AND BOARD OF ALDERMEN**  
**DIVISION 1. – GENERALLY**

**Sec. 2-28. - Administrative/supervisory committees.**

- (c) The duties of the finance committee shall be:
- (1) To review and recommend the operations budget to the board.
  - (2) To review and recommend changes to the city's purchasing and accounting procedures to the board.
  - (3) To review and recommend to the board procedures necessary to ensure the financial health of the city.
  - (4) To assume other responsibilities as may from time to time be assigned by the board.
  - (5) To review and recommend capital improvements to the board each fiscal year.
- (d) The mayor and city administrator shall serve on each of the committees mentioned in this section along with the appointed members of the board.
- (e) Additionally, the mayor and the board may appoint **three** citizens to serve on each of the committees. Appointees must be a citizen of the city or associated with a business operating inside the city limits.
- (f) Each committee shall adopt procedures as necessary to allow for the efficient administering of their assigned duties.

(g) Each committee member shall have a right to vote.

Section 3: This ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and approval by the Mayor.

Section 4: That should any section, sentence or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.

Section 5: That the City Clerk is authorized by this Ordinance to correct any scrivener's errors identified within this Ordinance.
