

AN ORDINANCE AUTHORIZING THE MAYOR TO SIGN A BUDGET AMENDMENT FOR THE PUBLIC INFRASTRUCTURE IMPROVEMENTS FOR THE ELEVATE BRANSON COMMUNITY VILLAGE PROJECT AND ALL THE DOCUMENTS RELATED THERETO.

WHEREAS, the City of Branson applied for a Community Development Block Grant (CDBG) program for the Elevate Branson - Elevate Community Housing in the amount of \$1,940,000.

WHEREAS, the Missouri Department of Economic Development has awarded the city \$1,940,000 in community development block grant funding; and

WHEREAS, the city accepted the community development block grant funding from the Missouri Department of Economic Development in 2021.

WHEREAS, a budget amendment is needed as part of this public infrastructure improvement project from CDBG program funding to cover the additional monies needed to construct the public infrastructure improvements for the Elevate Branson Community Village project.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BRANSON, MISSOURI, AS FOLLOWS:


Section 1: The Board of Aldermen desires to authorize the Mayor to sign a Budget Amendment for the Elevate Branson Community Village Project as specified in the related specifications and substantial conformity with the terms shown on Exhibit "1" and incorporated by this reference as set out here in full, together with such changes therein as shall be approved by the officers of the City executing same which are consistent with the provisions and intent of this legislation and necessary, desirable, convenient or proper in order to carry out the matters herein authorized. The Mayor, City Administrator, and other appropriate City officials are hereby authorized to execute the Budget Amendment and such additional documents and take any and all actions necessary, desirable, convenient or prudent in order to carry out the intent of this legislation.

Section 2: The Mayor or his designee is authorized and directed to sign on the City's behalf all documents necessary for the use of CDBG funds related to the public infrastructure improvements for the Elevate Branson Community Village project, and all attachments, exhibits, affidavits, and addenda or other document(s) which may be necessary to complete the project.


Section 3: This ordinance shall be in full force and effect after its passage and approval.

Director Kost,

The City of Branson, Missouri would like to request a procurement waiver for the Elevate Community Village Project 2019-DP-04. The City provided an adequate effort to provide fair and open competition, directly solicited nearly 2,000 professional construction contractors, and published the request for bids in the local newspaper, on the Southwest Missouri Council of Governments' website, the City of Branson's website, and Elevate Branson's website. Bids were due on April 30, 2024 by 3 PM. The City received one (1) bid for the project and is comfortable awarding the contract to the sole bidder, Emery Sapp and Sons. The bid provided by Emery Sapp and Sons was higher than CDBG funds allocated to these activities and will require increases in the corresponding construction budget lines. However, the City is confident in the ability of the firm and would like to request a procurement waiver so the project can move forward.
