2 **AN ORDINANCE AMENDING SECTION 2-201 OF THE BRANSON MUNICIPAL CODE**
3 **PERTAINING TO REMOVAL OF MEMBERS; ATTENDANCE AT MEETINGS.**

6 **WHEREAS**, RSMo Section 67.1979 Tourism Community Enhancement Districts addresses
7 removal of board members by a majority vote of the appointing governing body;

8
9 **WHEREAS**, the Board desires to align the Branson Municipal Code with statute.

10
11 **NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE**
12 **CITY OF BRANSON, MISSOURI, AS FOLLOWS:**

14 Section 1: It is the intention of the Board of Aldermen, and it is hereby ordained that the
15 provisions of this ordinance shall become and be made a part of the Branson
16 Municipal Code, and the sections of this ordinance may be renumbered to
17 accomplish such intention.

19 Section 2: That Chapter 2 – *Administration*; Article IV. – *Board, Commissions, Committees*
20 *and Councils*; Division 1. – *Generally*; Sec. 2-201. – *Removal of members;*
21 *attendance at meetings* of the Branson Municipal Code is hereby amended to read
22 as follows:

24 **CHAPTER 2 – ADMINISTRATION**
25 **ARTICLE IV. – BOARD, COMMISSIONS, COMMITTEES AND COUNCILS**
26 **DIVISION 1. - GENERALLY**

27
28 **Sec. 2-201. - Removal of members; attendance at meetings.**

29
30 (a) The mayor may, by and with the consent of the board, remove any member of any duly
31 formed board, commission, authority or committee for misconduct or neglect of duty.
32 **Exception: The board may by majority vote, remove without cause any member who**
33 **has been appointed by the governing authority to serve on the Tourism Community**
34 **Enhancement District Board and shall have the discretion to replace said member by**
35 **majority vote of the board with another qualified applicant.**

37 (b) A member of a board, commission, authority or committee shall be deemed to be neglectful
38 of his duty when, without the consent of the president or chairman of his board,
39 commission, authority or committee, he fails to appear at scheduled meetings of the board,
40 commission, authority or committee for three consecutive meetings.

Section 3: This ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and approval by the Mayor.

Section 4: That should any section, sentence or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.

Section 5: That the City Clerk is authorized by this Ordinance to correct any scrivener's errors identified within this Ordinance.
