

**AN ORDINANCE AMENDING 86-622 SCHEDULE II OF THE BRANSON MUNICIPAL CODE PERTAINING TO SPEED LIMITS.**

**WHEREAS**, the City Engineer has determined up on the basis of engineering and traffic investigation that the following speed regulations shall be changed to maximum speed of fifteen (15) miles per hour: all of Canal Street, Moore Street, Worthing Street, Christopher Drive, Lake Drive and Shore Drive

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BRANSON, MISSOURI, AS FOLLOWS:**

Section 1: It is the intention of the Board of Aldermen, and it is hereby ordained that the provisions of this ordinance shall become and be made a part of the Branson Municipal Code, and the sections of this ordinance may be renumbered to accomplish such intention.

Section 2: That Chapter 86 – *Traffic and Vehicles*; Article X. – *Schedules*; Sec. 86-622. *Schedule II – Speed limits* of the Branson Municipal Code is hereby amended to read as follows:

**CHAPTER 86 – TRAFFIC AND VEHICLES  
ARTICLE X. – SCHEDULES**

**Sec. 86-622. - Schedule II—Speed limits.**

(a) In accordance with section 86-151, the maximum speed limits on the city roads and highways shall be as follows:

<b>Location</b>	<b>Speed (mph)</b>
<b><u>All of Canal Street, Moore Street, Worthing Street, Christopher Drive, Lake Drive and Shore Lane</u></b>	<b><u>15</u></b>
All other streets and highways within the municipal boundaries, except all streets bounding city school property, or unless otherwise posted	25

34 Section 3: This ordinance shall be in full force and effect from and after its passage by the  
35 Board of Aldermen and approval by the Mayor.

38 or unconstitutional, such declaration shall not affect the validity of the remaining  
39 sections, sentences or clauses.
