**AN ORDINANCE APPROVING THE MUTUAL COOPERATION AGREEMENT WITH TANEY COUNTY FOR A 911 EMERGENCY TELEPHONE SYSTEM AND AUTHORIZING THE MAYOR TO EXECUTE THE CONTRACT.**

**WHEREAS**, Section 70.220, RSMo. authorizes any municipality or political subdivision to contract and cooperate with one another, and their elective or appointive officials for the planning, development, construction, acquisition or operation of public improvements or facilities and common services; and

**WHEREAS**, at a referendum election, the voters of Taney County, Missouri approved the establishment and operation of a county-wide 911 emergency telephone system and a levy to fund the system; and

**WHEREAS**, the Board of Aldermen and Taney County have cooperated to establish and maintain two Public Service Answering Points ("PSAP), with one being located in the Taney County Sheriff's Office, and the other being located in the Branson Police Department; and

**WHEREAS**, the Board of Aldermen desires to contract with Taney County for the a 911 Emergency Telephone System; and

**WHEREAS**, the mutual cooperation agreement with Taney County for a 911 Emergency Telephone System has been recommended for approval by staff; and

**WHEREAS**, the Board of Aldermen desires to enter into this mutual cooperation agreement.

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF BRANSON, MISSOURI, AS FOLLOWS:**

Section 1: The Board of Aldermen hereby approves the mutual cooperation agreement with Taney County for the a 911 Emergency Telephone System as specified in the related specifications and substantial conformity with the terms shown on Exhibit "1" attached and incorporated by this reference as set out here in full, together with such changes therein as shall be approved by the officers of the City executing same which are consistent with the provisions and intent of this legislation and necessary, desirable, convenient or proper in order to carry out the matters herein authorized. The Mayor, City Administrator, and other appropriate City officials are hereby authorized to execute the Agreement and such additional documents and take any and all actions necessary, desirable, convenient or prudent in order to carry out the intent of this legislation.

Section 2: This ordinance shall be in full force and effect upon and after its passage and approval.
