

# MINUTES

## REGULAR MEETING OF THE PLANNING COMMISSION CITY OF BRANSON, MISSOURI JUNE 6, 2023

### CALL TO ORDER

The Planning Commission of the City of Branson, Missouri, met in Regular Session in the Council Chambers of the City Hall on June 6, 2023 at 6:00 PM. The meeting was called to order.

### ROLL CALL

### PUBLIC COMMENT:

Chairperson O'Day asked if anyone was present wishing to speak to any items not on the agenda. He set a time limit of five minutes for each speaker.

Hearing none the meeting moved to the Regular Agenda Items.

### REGULAR AGENDA:

#### 1. APPROVAL OF THE PLANNING COMMISSION MINUTES FOR THE MAY 2, 2023 REGULAR MEETING.

Gary Groman moved to approve the minutes as presented, seconded by Rick DeJager.

#### 2. ELECTION OF CHAIRPERSON AND VICE-CHAIRPERSON.

Ruth Denham nominated Gary Groman as Chairperson. Brad Gore nominated Chuck O'Day as Chairperson.

There were 5 votes for Gary Groman and 4 votes for Chuck O'Day.

Gary Groman will serve as Chairperson of the Planning Commission for the 2023-2024 term.

Charles Hillis, Sr. nominated Rick DeJager as Vice Chairperson. As no other nominations were made, a roll call vote was performed.

Rick DeJager will serve as Vice-Chairperson of the Planning Commission for the 2023-2024 term.

3. REQUEST FOR A FINAL SUBDIVISION PLAT FOR STILLWOOD EAST, BRANSON, MO, 65616

Planning Director, Mark Colussy, presented the item as recommended by staff.

4. REQUEST TO VACATE A PORTION OF SUNSET LANE IN THE PINKLEY HEIGHTS ADDITION, BRANSON, MISSOURI.

Chairperson Groman asked if the applicant wished to speak.

Louis Chagoya, 701 Kingsway Dr, Branson MO spoke in favor of the request.

Chairperson Groman asked if the Commissioners had any questions. Hearing none, he called for a vote.

5. REQUEST FOR MUNICIPAL CODE AMENDMENTS TO CHAPTER 1 DEFINITIONS AND CHAPTER 94 ZONING OF THE BRANSON MUNICIPAL CODE CONCERNING MARIJUANA.

Planning Director, Mark Colussy, presented the item as recommended by staff.

Chairperson Groman asked if the Commissioners or any of the public had any questions or comments. Hearing none, he called for a vote.

Rick DeJager moved to approve the resolution as presented, seconded by Jesse Martinosky.

## REPORTS

Planning Director, Mark Colussy, reminded the Commission that July's meeting date has been moved to Thursday, July 6, 2023 at 6:00 PM. Colussy also asked for the Commissions thoughts on rezoning a parcel on 76 W Country Blvd, currently zoned entertainment, to a planned development to accommodate the request of a potential business development. Commissioners spoke in opposition to a rezone and expressed their support to preserving the entertainment district. He spoke about future items that may come to the Commission in the near future, including a rezone, a modification to definitions within code, a final plat, and a request for a special use permit.

Commissioner O'Day expressed his thanks to past Commissioners, Brenda Romine and Rick Davis, for their years of service to the Planning and Zoning Commission and the City of Branson.



