

2.00 REGULATIONS SPECIFIC TO EACH PARCEL

2.01 Zoning Uses – Normal uses allowed in this zoning district that apply to this development are outlined within this text under “Permitted uses” which are being requested by the developer are hereby submitted to the Planning and Zoning Commission for approval under the review and approval procedures set forth in the current adopted Zoning Ordinance. Uses allowed in this PD are as follows:

2.02 Specific uses per Parcel - The attached Parcel map Exhibit (“D”) illustrates the boundaries for each parcel and the allowed uses for each parcel are described below.

Business – Warehouse

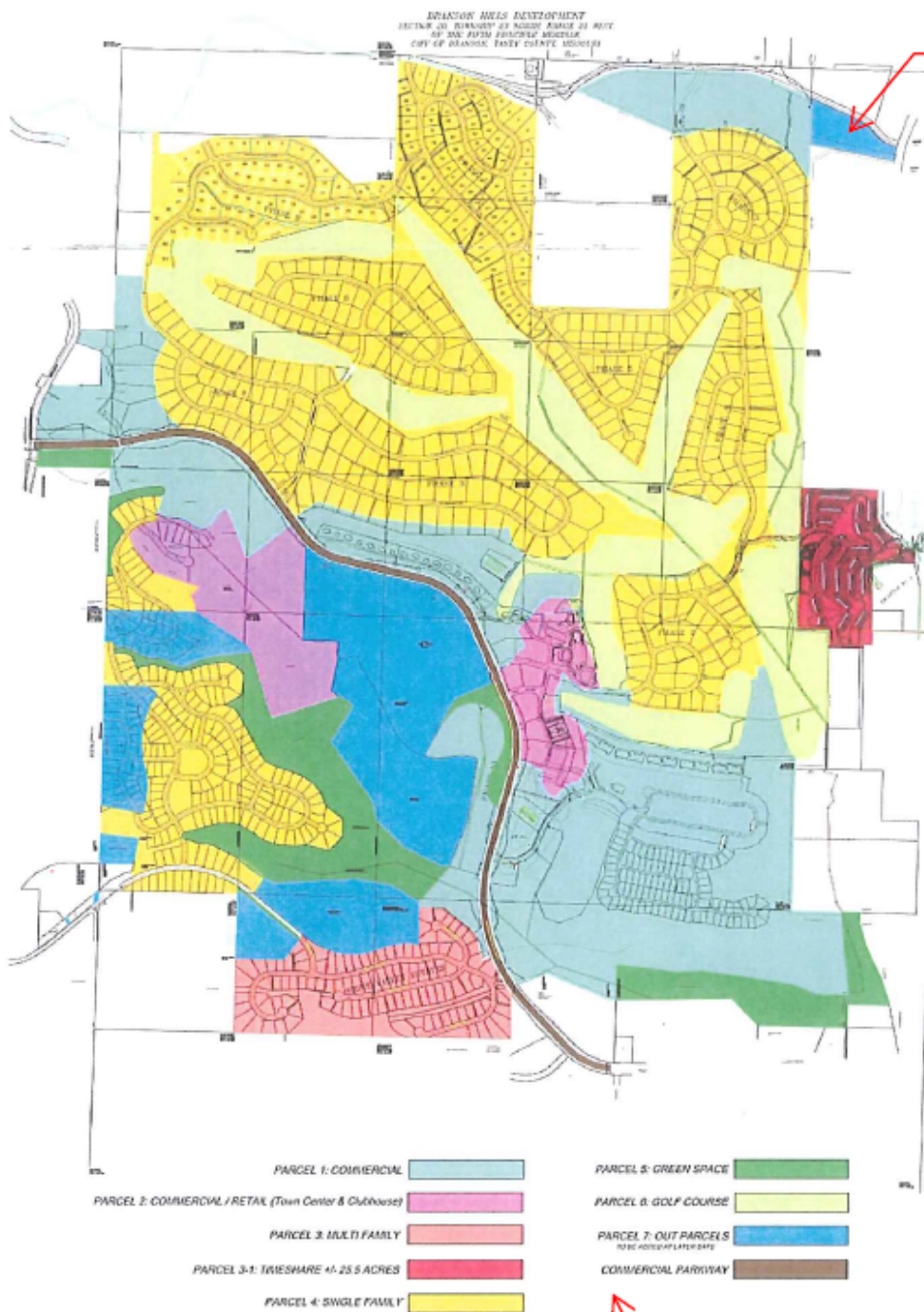
